



NOTE:

- Multiple-entry visa can be valid for entry up to 6 months from date of issue, but for a stay of only up to 15 days for each entry
- Period of stay is granted entirely at the discretion of the Consulate.
- Travelers, on arrival, must declare the amount of currency in bank notes, checks and travelers checks brought in to the country. The declaration is to be handed to the Exchange Control Office at the point of entry.
- Exchange an amount of \$50.00 at the point of entry with Kenyan currency.
- Import or export of local currency is not permitted.
- U.S. Vital Documents can assist with obtaining [U.S. Passports](#), whether new issue, renewal, or obtaining additional visa pages for a valid passport.
- Special requirements exist for U.S. [Official and Diplomatic](#) passport holders.

To apply for a Tourist Visa

Please submit the following items:

- Signed passport with at least 6 months remaining validity and at least one blank visa page
- 1 [Application Form](#) for Mozambique visa completely filled out and signed.
- 2 Passport-type photographs
- Completed [U.S. Vital Documents Order Form](#)
- Copy of round trip airline tickets or itinerary, or letter of confirmation from travel agent showing exit or onward travel from Mozambique
- Invitation letter from host in Mozambique or hotel confirmation (if applicable)

To apply for a Business Visa

Please submit the following:

- Signed passport with at least 6 months remaining validity and at least one blank visa page
- 1 [Application Form](#) for Mozambique visa completely filled out and signed.
- 2 Passport-type photographs
- Completed [U.S. Vital Documents Order Form](#)
- Copy of round trip airline tickets or itinerary, or letter of confirmation from travel agent showing exit or onward travel from Mozambique
- Letter typewritten on company letterhead. Letter must be signed by a company official other than the visa applicant and addressed to:

Embassy of Mozambique, Visa Section, Washington DC

The letter should contain the following:

- 🌐 Nature of business to be conducted
- 🌐 Name and address business contact in Mozambique
- 🌐 Guarantee of financial responsibility and return transportation for visa applicant

Visa Validity:

🌐 Tourist/Business Visas

Single entry: Valid for two months from date of issue for stay not to exceed 30 days, but can be extended upon approval of the Consul for up to ninety days.

Double entry: Valid for two months from date of issue and for stay not to exceed 30 days per entry.

🌐 Transit Visas:

Single entry: Valid for two months from date of issue and for stay of seven days

Double entry: Valid for two months from date of issue and for stay of seven days for each entry.

Fees:

🌐 U.S. Vital Documents Service Fee:

\$50.00 per visa

🌐 Consular Fee:

\$20.00 for a Single entry visa

\$40.00 for a Double or multiple entry

🌐 Shipping Fee

\$12.00 FedEx 2nd Business Day

\$19.00 FedEx Letter (Priority Overnight)

\$30.00 FedEx Letter (Saturday Delivery)

Additional fee may apply to overseas shipping and overweight packages.

Payment:

Include credit card authorization or a check or money order payable to **U.S. Vital Documents** for Service Fee per visa, consular fee per visa, and return FedEx shipping fee.
